PSB Accomplishments to Date

- 1. 2009 Received \$2,500 state funding to promote multiple events each month for the "Year of Active Transport" in 2009
 - a. Distributed 150 safety flashers, 1000 reflective bracelets to 5th grade students, safety vests and safety yellow "Year of" long-sleeve t-shirts
- 2. 2009 published monthly editorials in The Dominion Post
- 3. 2009-10 Developed Pedestrian Safety Plan, attended meetings for all neighborhood associations, and presented it to community in forum hosted by The Dominion Post (collecting 129 signatures in support of Plan in online petition to City Council)
- 4. 2009, June hosted discussion of MUB improvements to rail-trail for 2010
- 5. 2009 conducted observations of signalized intersections
- 6. 2009, November hosted Police Chief Scott to discuss parking on sidewalks
- 2009 conducted 30 hours of pedestrian/vehicle observations at multiple locations (May-July) details in Jan, 2011 minutes; 57% of pedestrians crossed in crosswalks; only 5% used pedestrian signal call button; 63% crossed without signal or against traffic; 23% of drivers stopped at lights within crosswalks; 27% of drivers & 14% of pedestrians were on phone or "distracted"
- 8. 2010 City Council "approved of the Pedestrian Safety Plan's Goals and Objectives" September 7, 2010
- 9. 2010, April hosted City Manager (Boroff) to discuss code enforcement and Pedestrian Safety Plan
- 10. 2010, April Established priority list for one-time \$200,000 made available by City in 2010-11 budget (to improve Suncrest Middle School and Primary School areas), but no action taken by City
- 11. 2010, October Conducted mobile lab of systemic issues on state routes at MPO Conference
- 12. 2011, May hosted City Manager Terrence Moore to discuss City's Five Year Capital Improvement Plan
 our pedestrian infrastructure improvement priorities will serve as guidance for pedestrian-related
 spending, though City still not dedicating funding for pedestrian infrastructure

- 14. 2011 hosted two downtown safety walkabouts (May & October) with Dr. Ron Eck
