THE SIERRA CLUB, INC.'S RESPONSE SUPPORTING REOPENING FOR SOLE PURPOSE OF ADMITTING PJM REPORT INTO EVIDENCE

The Sierra Club, Inc. supports the motion to reopen filed by Thomas Hildebrand for the purpose of admitting into evidence the May 21, 2008 update report from PJM.

The PJM's May 21, 2008 update reports a series of scenarios resulting from the 2011-2012 Reliability Pricing Model/Base Residual Auction. Although most of scenarios suggest adjustment being required in the absence of th TrAILCo line at least one scenario, the fourth, suggests a 99% loading of the line, and no remaining loading or reliability margin, but also no reliability violation.

In short, if the alternatives assumed in the fourth scenario are adopted – and those alternatives are explained in the PJM report – no TrAILCo line is required in order to avoid the June 2011 reliability violations upon which TrAILCo predicates its application in Case No. 07-0508-E-CN before this Commission.

There are any number of questions raised by PJM's May 21, 2008 report, not all of which need to be addressed here. It is sufficient for present purposes that the May 21, 2008 report

underscores more strongly than any legal argument could the absence of any compelling evidence to rush to a decision on the March 2007 TrAILCo application based upon the obviously obsolete 2006 RTEP.

It is, frankly, inconceivable that the Commission would <u>not</u> reopen, at a minimum, to accept the May 21, 2008 report which bears directly on the core need issue before this Commission. Plainly, the Virginia State Corporation Commission felt compelled to consider the matter and reopened the TrAILCo proceeding before it. No persuasive reason can be suggested for ignoring this evidence.
