'However, Justice claimed he didn't want this bill to limit coal-based energy production in the Mountain State, and that is why he vetoed House Bill 5528.'"I just vetoed a bill that was known as an AEP bill. First and foremost, I would tell you that AEP is a good company, at least I think, but really and truly what I believe is that what is going on with the higherups to try and shove coal to the background, I don't like that," Justice said.

The truth is that some candidates have continued to shove the truth about fossil fuels under the rug. Lower birth weights, preterm births and poor birth outcomes are of grave concern and do not align with WV's laws about preserving life. A margin of difference could be made by strengthening regulations in WV fracking permits. WV currently allows fracking at a distance of only 625 feet to an occupied dwelling and the proximity allowed to various water sources is absolutely shocking. These 'restrictions' are available for review at the DEP website under <a href="H6A">H6A</a><a href="Checklist">Checklist</a> for Horizontal 6A Permit (See at the end of WW-6A7 Well Restrictions Forms.) Delegate Evan Hansen's <a href="HB 4906">HB 4906</a> unfortunately remained stagnant in the House Energy and Manufacturing committee.

That salty brine that may be found deicing our WV highways is much more than just rock salt and is likely to be coupled with fracking waste. WV is one of 13 states that made agreements to deposit these toxic chemicals on their roads to deice roads. Disposing of fracking waste in plain sight is certainly one way to get rid of it. The lethal chemistry inherent in fracking formulas (some of which are protected as intellectual property) and the residual radioactive components that result from deep horizontal drilling make each company's waste unique. Lubricants, a source of carcinogenic PFAS, are also a component of fracking fluids.

Candidates must be expected to address the ongoing problems of fossil fuel pollution and the disposal of resulting waste materials from toxic extraction methods. There will be only more troubled waters if renewable energy generation is curtailed from the future of energy production in WV.

### Cabell County Excess Levy

Cabell County voters loudly declared their opposition to cutting funding to libraries and parks in the excess levy, by a vote of 64 to 36. The excess levy has been resoundingly approved since 1967. Now there is time to restructure the levy for the November election, which superintendent Saxe says he is willing to negotiate.

It is possible to bring back the previous percentage split or other arrangement. Though the Supreme Court said it was not legal to require this, it is all right for the Board of Education to approve it. There is time before the new five-year levy expires to work with the legislature to plan new excess levies for individual funding.

In any case, the League of Women Voters supports adequate funding for all three agencies, which is closer to possible with the old excess levy funding structure. It is clear we need funding for schools along with libraries and parks. West Virginia has always needed more funding to make these truly adequate, but we come closer sharing as we used to. Fortunately, we have an opportunity now to work together to provide better for schools, libraries and parks. We need to begin now.
